



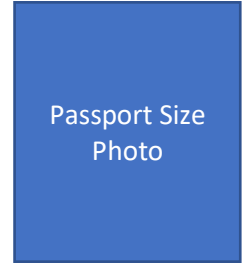

MEETING PROCEDURES

IENK Weekly Meetings will be organized during weekdays or weekends as preferred by the Chapter President and Core Committee Team in every week. Members need to arrive on time and be present for the entire meeting. Absenteeism is generally not permitted in IENK. However, for unavoidable reasons absenteeism up to a maximum of 12 instances is permitted per year. In case of more than 12 instances of absenteeism the Chapter Core Committee Leaders will take necessary action against the specific member without any prior intimation. Further, the Member will have to ensure that he deposes a suitable substitute in the Managerial rank to represent the organization in the IENK meeting during his absenteeism. Nonattendance of the Member & Substitute, will be considered and treated as absenteeism on the part of the Member, which will not be appreciated by the Chapter. For instance, with four (4) IENK Meetings scheduled every month, the total IENK Meetings scheduled for any year will be a total of forty-eight (48) Meetings. The maximum number of exceptions permissible for participation of any Member will be four (4) Meetings only. In short, every Member will have to ensure his / her active participation in 48 meetings during the year. More than 12 absenteeism for IENK Weekly Meets by any Member, will result in forfeiture of the Membership Fee and the Membership fee will not be refundable in this case. More than 12 absenteeism for IENK Weekly Meets by any Member, will result in forfeiture of the Membership Fee. Members are expected to be responsibly and groomed for every IENK Meet whether Virtual or Physical. IENK Members are to wear the approved uniform Dress Code of Half-Coat Suit in Dark Blue Colour

MEMBERSHIP ENROLLMENT PROCEDURES

1. The aspiring applicant for IENK Membership, should necessarily and exclusively be part of the Any Industry with his / her Business activity being directly or indirectly related to the various segments of the Any industry as listed in our website.
2. The organization represented by the Member should be a Registered Business in India in the form of a Public Limited Company, Private Limited Company, Partnership or Sole Proprietorship Firm, LLP or a OPC (One-person Co. registered under Companies Act of 2013). The Member will have to record their valid GST Registration Number and PAN Number with their application.
3. IENK's Membership minimum eligibility criteria for any registered company being operations in the same segment for which membership is applied, along with registration GST, MSME, Register of Companies as applicable.
4. Builders, Architects and Engineers operating as Individual decision makers and influences in the Any industry are endorsed for IENK Membership, on expression of their interest. However, proof of their operations for the immediate past three (3) years need to be submitted. The required documents for Proof of experience could be submitted in the form of GST Registration, Company / Firm Registration or PAN Registration.
5. Individual applicants to be enrolled as Engineers, will have to qualified Civil Engineering Degree / Diploma holders with a minimum Professional experience, with proof of Income-tax returns submitted.
6. Other segments for which individual applicants are permitted Professional experience is mandatory and essential in all fields.
7. Members must represent their primary occupation and not a part-time business.
8. While IENK's Core committee will submit recommendation for Membership Admissions based on the applications received, the Sole discretion of Membership selection or rejection, for any chapter will rest with the Board of Directors of M/s. IESK Kedndra Foundation., whose decision will stand final and irrevocable.
9. In the event of an applicant considered to be completely eligible for an already occupied segment in any chapter, IENK's Membership committee may provide membership options for the applicant in alternate chapters of IENK as per the applicant's choice.
10. An individual member cannot be part of an alternate IENK chapter that allows only one person per profession and whose primary purpose is to pass referrals to one another, because it substantially reduces their commitment to the primary chapter members.
11. Corporate Businesses who prefer to be Members in multiple IENK Chapters are permitted to do so. However, they will have to pay the Premium Membership Fee applicable for the same (calculated as -Basic Subscription Fee (Rs.20,000/- + 50% Additional Fee plus applicable GST). However, it needs to be noted that the company will have to depute a different representative for each IENK Chapter. A single representative of the same company wouldn't be offered Membership in multiple IENK Chapters.
12. Members are expected to bring bona-fide referrals and visitors to their Chapter of IENK. The Chapter PRASIDENT will review each Member's number of referrals and/or visitors brought in, for suitable recognition of the Member's efforts.
13. On no criteria will any Business or Company, not related to the Any industry be entertained or permitted to be enrolled as a Member of IENK. However the concern Core Committee will take a decision based on the ground reality and not deviate of IENK Policies.
14. The Member representing his / her company is anticipated to hold the position of a Director, Proprietor, Partner, PRASIDENT, while the substitute participant for any meeting representing the Company will have to hold at least a Managerial Position.
15. Members who wish to change their classification must submit a new membership application and obtain approval from the IENK Admin Office for the classification change. However, this will be subject to availability of Membership space in the specified classification.
16. In case of any problem arising due to a member's action, the Chapter President may intervene and resolve the issue at his/ her discretion, while documenting the incidents and corrective action taken, for review of the Core Committee of the Chapter.
17. If a member acts against the rules of the IENK, acts in a manner that disrupts the unity of the chapter, or behaves erratically in the chapter, he may be expelled from the Chapter as decided by the Core Committee Team with the concern of Chapter President. The Core Committee holds the authority for initiating the required corrective action to be taken against any Member, in the event of his/ her failure to comply with the policies and / or the code of ethics of IENK.
18. Aspiring Applicants who are active Members of other Referral Networking Forums are not eligible for IENK Membership. Their Membership in IENK will be confirmed, only after submission of suitable proof confirming their membership closure from the alternate Networking Forum.

TERMS & CERTIFICATIONS

By acknowledging your accord below, you hereby agree to receive communications and correspondence from us relating to IENK and further agree that IENK may share your information and details with other IENK Members, Affiliates, and all parties involved, in order to provide you with the required services as IENK Member.

1. RIGHTS: IENK is an initiative of M/s. IESK KEDNDRA FOUNDATION a registered company under the Companies Act, 2013.

2. NOTION: The IENK Forum will act as a platform for referral sharing among the Members and Participants. This is exclusively for the fraternity of the Any Industry. IENK proposes to organize the congregation of Any Professionals as an Event, exclusively to provide successive and sequential Marketing Services for the participants and the initiative is no way intended to be measured as an Enterprise, Society or Association. IENK is strictly a Marketing Service Provider.

3. IENK promotes Business connects among a Group of Any Industry Professionals, with maximum of eighty (150) Members in a single chapter. For instance, Each Chapter will be formed by a Group of 150 Members representing varied segments of the Any industry together.

4. Core Committee (PRASIDENT, Secretary, Joint Secretary, Treasurer, Membership Development Chairman, Public Image Chairman and others of each Chapter have final authority relating to classification conflicts & other conduit of Interest.

5. The IENK will stringently operate within the boundaries of a Referral Networking Forum facilitator and will no way be held responsible for any Business Transactions / Money Transactions Financial agreements between the participating members.

6. All disputes arising out of or relating to the Member's Participation in IENK shall be resolved by binding arbitration in accordance with the laws of the country of India, outside the Forum precincts, subject to the jurisdiction of MADRAS HIGH COURT, between the Members involved. IENK will no way be liable or held responsible

7. IENK will stand firm on providing a favourable environment for every Member irrespective of the Product / service dealt with by the Member in the Any industry. Hence, Groupism, Favouritism or Demotivating talks within the Forum will be considered as grave disruptions for the Chapter's performance and the Member found to be responsible for such behaviour will invite strict disciplinary action, resulting in immediate expulsion and forfeiture of the Membership fee (also Refer clause 17 under Membership Enrolment Procedure).

8. Every IENK Member hereby undertakes to commit that he/ she will not indulge or participate or be part of any other Business Networking forum, while being a member of IENK. Should the Member decide on discontinuing his Membership with IENK, He/ She, hereby commits that He / She will not initiate, create, form, establish any alternate Business Networking forum identical to IENK for a period of 3 (three) years further to expulsion from IENK.

9. IENK Policies are subject to change. All proposed policy changes will be reviewed and finalized with the directors of IENK kedndra Foundation.

10. The applicable Annual subscription charges payable for the IENK Membership by Individuals will be Rs.12,000/- and for Corporate Businesses will be Rs.24, 000/-. GST will be applicable and extra. The subscription is valid for a period of 12 months from the date of joining and needs to be renewed by the end of the subscription period.

11. The Membership Fees cannot be transferred from one person to another, unless the fees were paid by the same company. The Membership is not transferable between companies.

12. The Renewal of Membership will be consider based on previous year referral given to the chapter members and co-operation with the fellow members and all other discipline aspects will be taken as key factors. However, the Regional Director and PRASIDENT, will be taken the final decision of the concern membership for Renewal.

13. The Member should not create any separate WhatsApp Group, Telegram Group, Facebook Group and any form of Chatting Groups. It will be treated against the IENK Policy.

14. The IENK Chapter Meetings (other than Virtual Meets) will be organized in the Banquet facilities of Star Rated Hotels. All expenses incurred towards organizing the meet will be shared among the Members and Visitors are chargeable in addition. The Meetings will include Weekly Referral Meets, Review Meet, Training Programs and all other Meetings.

15. All payments will have to be made in favor of M/s. IESK KEDNDRA FOUNDATION vide Cheque/ Demand draft/ RTGS or UPI Modes, along with the duly filled Application form.
